Good morning,

On Thursday, March 10th, the Arts and Humanities 2 Panel of the ASC Curriculum Committee reviewed a new proposed minor in Environmental Arts and Humanities. Please see below for the Panel's feedback:

The Panel unanimously approved the minor with one contingency:

- **Contingency:** The Panel asks that the following small errors be corrected before the proposal is reviewed by the full Arts and Sciences Curriculum Committee. Overall, however, they believe this to be a great new minor proposal:
 - On page 3 of the proposal, under the "Ohio Programs" section, the first sentence calls this program a proposed "major". Please correct this to proposed "minor".
 - On page 5, under "Proposed Curriculum", there is a sentence that states, "Students pursuing the minor may overlap up to 6 credit hours of GEs and may count up to 6 credits of overlapping courses with their major program." However, 12 credit hours must be distinct from the major and/or additional minors. Since this is a 12-credit hour minor, all credit hours must be distinct from a student's major program.
