On Monday, March 21<sup>st</sup>, the Arts and Humanities 1 Panel of the ASC Curriculum Committee reviewed a new course and distance proposal for French 2101.61. Please see below for the Panel's feedback:

French 2101.61 was unanimously approved with the following recommendations:

- **Recommendation:** The Panel recommends correcting the course number throughout the course to 2101.61, as currently it is frequently listed as 2101.51.
- **Recommendation:** The Panel recommends updating the Title IX statement within the course syllabus, as Kellie Brennan is no longer the University Title IX Coordinator.
