- For further reference, please see the attached PDF of the course proposal materials for Public Affairs 2150, in which the repeating language is highlighted in yellow. This language, although labeled as Goals 1-2 and ELOs 1.1, 1.2, 2.1, & 2.2, is actually the language for Goals 3-4 and ELOs 3.1, 3.2, 4.1, & 4.2. Please revise accordingly.
