On Wednesday, September 6th, the Themes 2 Subcommittee of the ASC Curriculum Committee reviewed a GEN Theme: Citizenship for a Diverse and Just World request for Sociology 3302.

The Subcommittee voted to not approve this proposal for inclusion within the GEN Theme: Citizenship for a Diverse and Just World. Please see below for their feedback:

- The reviewing faculty would like to thank the course proposer for the revisions provided to this submission. However, they are still unable to see how this course will successfully engage with the Citizenship Goals and ELOs of the General Education program. They do not see a path forward with this proposal without the course being fundamentally reworked and rethought. Therefore, at this time, they are voting to not approve this course within the Citizenship category. They would like to emphasize, however, that they believe a course on technology and citizenship could be a valuable inclusion within the GEN Theme category. However, this course does not seem like it is the correct match.

I will return Sociology 3302 to the departmental queue via curriculum.osu.edu to allow you to cancel this request.
