Good afternoon,

On Monday, February 19<sup>th</sup>, the Themes II Subcommittee of the ASC Curriculum Committee reviewed a High-Impact Practice: Interdisciplinary and Integrated Collaborative Teaching request for HCS/AGSYSMT 3586.

I am pleased to report that the reviewing faculty unanimously approved the request, with two contingencies and one recommendation:

- **Contingency:** The Arts and Sciences Curriculum Committee recently updated their list of required syllabus statements for all syllabi to include the statement on religious accommodations. This new, required statement is a result of a directive by the Executive Vice President and Provost and [can be found here on the ASC Curriculum and Assessment Services website](#). The Subcommittee thanks you for adding this statement to your course syllabus.
- **Contingency:** The reviewing faculty ask that the exclusion section on the curriculum.osu.edu form for the HCS version of the course to updated to be “AGSYSMT 2580 or AGSYSMT 3585 or AGSYSMT 3586 and HCS 3585”.
- **Recommendation:** The reviewing faculty recommend updating the Student Life – Disability Services and Mental Health statements, as they were updated for the 2023-2024 academic year. The most up-to-date statements can be found on the [ASC Curriculum and Assessment Services website](#).

I will return the courses to the departmental queues via curriculum.osu.edu in order to address the feedback above.
