Apologies for the delay. Thank you for sending the updated syllabus. It was helpful for our faculty to understand the broader context for the course and to see some potential readings. We appreciate that you modified the title to emphasize the public opinion component – and recognize that this not the final title.

We are supportive of the class given this new title and the focus of the proposed readings.

I also want to reiterate that if there is any potential for this to serve as an advanced writing course – we would see value in funneling ENR students to it. We will be using a 2000-level writing class coupled with our capstone courses to meet the Advanced Writing embedded literacy requirement in the new GE. But we foresee enrollment problems with our 2367 course and could use an additional course for our students. Just something to consider as you continue to develop the course.

Thank you for the quick reply. Not to slow the process down, but I wanted to follow up with a couple of things. There is some initial feedback from our faculty that might be helpful –

- One of our faculty members who is serving on the Lived Environments GE Theme committee indicated that the syllabus will need additional detail – including readings – before that committee would be able to review it. I know that’s a bit down the road, but several of our faculty members have suggested that it’s difficult to get a handle on the course without that kind of information
- There was a suggestion to shift the title of the course to indicate that there is a focus on public opinion and/or media literacy. The current “perceptions” title could give the impression that the course overlaps with ENR 3400 (Psych of Environmental Problems). The syllabus suggests that the overlap with 3400 is pretty minimal, but the title could be problematic.
- It might be helpful if there was a way to contain the focus on environmental issues to those that are directly related to food production and food systems. That still leaves a fairly broad swath of environmental issues, but it might also reduce concerns about overlap.

In addition, Jeff brought up an idea that we wanted to get your opinion on. If this proposed course meets the learning objectives of a second writing class, SENR would certainly see value in directing some of our students to it. Our own 2367 is facing enrollment problems and it would be good to have another, relevant, course to which to send students. It could also potentially serve as an Advanced Writing embedded literacy course for your students if there is a need for that. I don’t know if a second writing course was what you had in mind for this course, but we want to let you know that SENR might be able to boost enrollments if you went that direction.

Hi, Jeremy,

AGRCOMM 2330 was designed to 1) serve our Agricultural Communication students as an introduction to the major issues that influence public perceptions of agriculture and 2) to fit into the Lived Environments theme. It wasn't intended to specifically fit into the Sustainable Agriculture major.

For context: We've noticed that many AGRCOMM students begin our program with only a limited understanding of agricultural and environmental issues, often based on their personal experiences, and we want to help them understand the myriad issues they may have to grapple with as agricultural communications professionals working with diverse audiences. At the end of the day, we conceptualize it as a sort of public opinion and media literacy course. We really want the class to encourage students to consider how different groups of people approach potentially contentious issues and how they can use communication as a tool to understand and potentially change perceptions.

We aren't certain who will teach the course or what the specific readings might be, as we are in the midst of a faculty search with a focus on hiring someone with this expertise area. Dr. Joy Rumble, our faculty member housed at Wooster, specializes in public opinion research and has expressed interest in teaching it if it isn't taught by our new hire. We'd discussed working with content experts on each topic to share basic background information, and presenting students with popular-press literature (e.g., news media coverage of an issue from a variety of sources, popular media, advertisements, etc.) to introduce them to different viewpoints and portrayals.

- Was this class designed to fit into the undergraduate Sustainable Agriculture major? It would be great to understand if there is a broader context for which this class fits into. This question partly relates to the Intro to Sustainable Ag class (ENR 3100 - <https://senr.osu.edu/courses/enr-3100>) that was recently offered for the first time). It helps us understand how this class is being positioned – other than aiming for GE thematic areas
- Do you have a sense of who might teach the course and what some of the readings might be? That also helps us think about how much of the focus will be on food production/systems and how much will focus on explicit environmental issues.

Thanks in advance. I realize you may not have perfect answers to all of these questions yet, but really just having a sense of the broader context surrounding the creation of this course would be helpful.


