Good afternoon,

On Thursday, September 1, the Social and Behavioral Sciences Panel of the ASC Curriculum Committee reviewed a course proposal for Speech and Hearing Science 2230.

The Panel unanimously approved the request with four recommendations:

1. *Recommendation:* The Panel recommends that the department include page numbers for all readings so that students are aware of work expectations from week to week.
2. *Recommendation:* The Panel recommends that the department include information regarding the role of the TA that outlines who students should contact (the instructor or the TA) with questions about different kinds of issues.
3. *Recommendation:* The Panel requests that the department provide students with information about where to purchase, rent, or otherwise procure the required text for the course (syllabus pg. 2 under “Course Materials and Technologies”).
4. *Recommendation:* The Panel offers a friendly reminder that the in-person syllabus (submitted for comparison purposes only) has an outdated Title IX statement. The most up-to-date statement can be found here:
