Good afternoon,

On Thursday, September 1, the Social and Behavioral Sciences Panel of the ASC Curriculum Committee reviewed a course proposal for Psychology 6851.

The Panel unanimously approved the request with **one contingency** and *2 recommendations*:

1. **Contingency:** The Panel requests that the department remove references to the practicum aspect of the course (syllabus pg. 2 and pg. 4) to align the syllabus with the Course Change Request form (pg. 1 under “Course Change Information”), which says that the department’s reason for the request is the removal of the “practical piece” of the course.
2. *Recommendation:* The Panel recommends that the department adjust the meeting times for the course on pg. 7 of the syllabus (under “Logistics of the Course; Mode of delivery”) to align with the new 80-minute class time that is outlined on pg. 1 of the syllabus.
3. *Recommendation:* The Panel recommends that the department adjust number (28) of In-Class Activities (syllabus pg. 4) to align with the “Grade Earning Matrix” (syllabus pg. 5) which indicated 13 In-Class Activities.

I will return Psychology 6851 to the department queue via curriculum.osu.edu in order to address the Panel’s requests.
