Dear Brad and Members of the Arts and Sciences Curriculum Committee,

At its meeting on March 23, 2023, the Arts and Humanities 2 Panel of the ASC Curriculum Committee reviewed and unanimously approved the following changes to the English minor:

- 1) To reduce the minor's current 15 credit hour requirement to 12 credit hours. This change in credit hours will align the English minor to other minors such as Asian American Studies, Classical Humanities, History, and Women's, Gender, and Sexuality Studies, which require 12 credit hours.
- 2) To add new courses developed for the GEN to the writing requirement portion of the minor.

Undergraduate Studies in English prepares students to think critically about texts; to construct sound arguments based on evidence; to write elegantly and persuasively; and to understand the historical and cultural contexts in which texts are produced, disseminated, and received. Through the Department of English, undergraduates have access to over 120 courses on topics ranging from Shakespeare to digital media studies, from Romanticism to popular culture, from 20th-century fiction to contemporary disability studies, from traditional grammar to literary publishing, from folklore to narrative theory, from creative nonfiction to business and professional writing, and from rhetoric to film analysis. Although minor programs are not required for graduation, students are encouraged to pursue them. Minors are especially useful to pre-professional students to indicate a breadth of interest that goes beyond narrow specialization. For further information and/or to have your English minor program approved, please schedule an appointment with the English Advisor listed above.

The minor in English consists of 12 hours at the 2000-level or above, which must include:

- One of the following writing courses: English 2367.05, 2367.07S, 3020, 3304,3305, 3379, 3398, 3405, or 3467S. Since either English 3379 or 3398 is required of all English majors, English minors who wish to enroll in 3379 or 3398 must seek permission of the instructor or an English Advisor, who will sign the student into the course as space allows.
- At least one literature course [see attached list]
- At least 6 hours of coursework at the 3000-level or above.

#### **English minor program guidelines**

The following guidelines govern this minor:

<u>Credit hours required</u> A minimum of 12 credit hours. 1000 level courses shall not be counted toward the minimum. At least 6 credit hours must be 3000-level courses or above.

<u>Transfer and EM credit hours allowed</u> A student is permitted to count up to 6 total hours of transfer credit and/or credit by examination.

Overlap with the GE A student is permitted to overlap up to 6 credit hours between the GE and the minor.

## Overlap with the major and additional minor(s)

- The minor must be in a different subject than the major.
- The minor must contain a minimum of 12 hours distinct from the major and/or additional minor(s).

#### Grades required

- Minimum C- for a course to be counted on the minor.
- Minimum 2.00 cumulative GPA for all minor course work.
- Course work graded Pass/Non-Pass cannot count on the minor.
- No more than 3 credit hours of course work graded Satisfactory/Unsatisfactory may count toward the minor.

X193 credits No more than 3 credit hours.

Minor approval: The minor is complete if a student takes the above coursework and meets the requirements on this sheet. Meeting with an advisor in the academic unit offering the minor is not required.

<u>Changing the minor</u> Any changes must be approved by the college/school advisor.

Dear Professor Leite,

Thank you very much for both your support of our programmatic changes and your questions. Let me answer each of them below:

## Major

- 1. Students typically select their Specialization (formerly Concentration) either when they first declare the major, or within a semester or two after declaring the major. In both cases, they do so with their Academic Advisor in the Department of English.
- 2. You are correct, there is 7.7% reduction in the major. I don't know if this was added to osu.curriculum.com or not. While I add individual courses to the portal, I did not add program changes to the portal but instead have relied on the indispensable Bernadette Vankeerbergen.
- 3. The reason Appendix A lists the "Specializations" as "Concentrations" is that these are our old advising sheets and we formerly called our tracks, "Concentrations." During my discussions with ASCC (and Bernadette), she suggested that the university's preference was to refer to major tracks as "specializations," since the nomenclature of "concentration" referred to something different.

#### Minor

- 1. Again, you are correct: there is 20% reduction of credit hours for the minor.
- 2. My apologies for the symbols. They are used on our major forms to designate courses that serve multiple functions. § = courses that are also GEN Theme courses. ∞ = a course that fulfills the EL Technology for the major. The former may make sense to keep (since many minors might like to use GEN Theme courses to fulfill courses in minor). The latter does not make sense to retain.

Would you like me to make the changes on the documents? If so, where would it be best to add the required documentation of % change?

Dear Prof. Hewitt,

I hope this email finds you well.

I write as Chair of the Council on Academic Affairs' subcommittee reviewing the aforementioned proposals, the last step of review before we move them for discussion and vote by the entire council. We are supportive of the proposals, with some questions that I believe you will be able to address and list below.

## Re: major--

- When we read "All students will now be able to identify the CW Specialization when they declare the major." on pdf p. 6 (end of section 2), could you please clarify what "identify" means here by perhaps describing the process with a few more details?
- In revision proposals, we expect to see the percent of curricular change involved in the revision (this is to be compliant with ODHE requirements). Perhaps that was entered separately into curriculum.osu.edu but the pdf we have does not contain a copy of those pages. Could you please confirm that?
  - From my read, it may be 3/39 (or a 7.7% reduction) in the major.
- An editorial suggestion: If concentrations are now being referred to as specializations, why not edit Appendix A (advising sheets) to reflect that?
  - Perhaps it would make sense to add proposed advising sheets to contrast with the current ones (or highlight the changes to the current ones).

#### Re: minor--

- Similarly to the point above, what is the percent of curricular change here?
  - Is it a 20% reduction (3/15) in the minor?
- Could you please clarify what the new GE courses are and what the symbols before some of the course numbers represent on the last page of the pdf?

We look forward to your clarifying thoughts and commend the department for proposing these revisions aimed at attracting more undergraduate students to the major and the minor in English.
