On Thursday, August 31st, the Natural and Mathematical Sciences Subcommittee of the ASC Curriculum Committee reviewed a new course and distance learning request for EEOB 3495.

I am pleased to report that the Subcommittee unanimously approved the request with three recommendations:

- **Recommendation:** The Subcommittee offers the friendly recommendation to update the Student Life – Disability Services statement in the course syllabus (on page 11, as they recently updated it for the 2023-24 academic year. The most up-to-date Student Life – Disability Services statement can be found on the ASC Curriculum and Assessment website at: <https://asccas.osu.edu/submission/development/submission-materials/syllabus-elements>.
- **Recommendation:** The Subcommittee recommends updating the mental health statement (as found on page 11) on the course syllabus, as the National Suicide Prevention Lifeline phone number was updated. - **Recommendation:** The Subcommittee would like to kindly bring to the department's attention that the University recently approved a new religious accommodation statement for course syllabi. EEOB 3495 will continue through the approval process. My office will advance the course to OAA.
