On Wednesday, November 15<sup>th</sup>, the Themes 2 Subcommittee of the ASC Curriculum Committee reviewed a new GEN Theme: Citizenship for a Diverse and Just World request for Classics 3301.

I am pleased to report that the Subcommittee unanimously approved the request with two contingencies:

- **Contingency:** The Arts and Sciences Curriculum Committee recently updated their list of required syllabus statements to include a statement on religious accommodations. This new, required statement is a result of a directive by the Executive Vice President and Provost and [can be found here on the ASC Curriculum and Assessment Services website](#). The Subcommittee thanks you for adding this statement to your course syllabus.
- **Contingency:** The reviewing faculty noticed that the course syllabus sometimes refers to the course proposal as Classics 3201. They ask that this be corrected throughout the provided course documentation, given that this will become the syllabus-of-record.

I will return Classics 3301 to the departmental queue via curriculum.osu.edu in order to address the Subcommittee's feedback.
