Subject: Microbiology 6030

Good afternoon,

On Thursday, September 14th, the Natural and Mathematical Sciences Subcommittee of the ASC Curriculum Committee reviewed a new course request for Microbiology 6030.

I am pleased to report that the Subcommittee unanimously approved the request with one comment, two contingencies, and two recommendations:

- **Comment:** The Subcommittee believes that this course will be both an excellent inclusion with the Microbiology graduate program and an incredibly helpful course for their students.
- Contingency: The Subcommittee asks that language be provided in the syllabus that is inclusive of a student (such a student in the Master's program) that is not writing a dissertation. Currently, under the "Assessment" section on page 1, it states that students will draft a written component based on their own dissertation research project. However, a student enrolled within the Master's program would not be completing a dissertation, and therefore, it is difficult to see how that particular student would be assessed. Additionally, the Subcommittee asks the language mention "pre-candidacy Master's students" be clarified, as MS students do not take a candidacy.
- **Contingency:** The Arts and Sciences Curriculum Committee recently updated the list of required syllabus statements for all syllabi within the College to include a statement on religious accommodations. This new, required statement is a result of a directive by the Executive Vice President and Provost and <u>can be found here on the ASC Curriculum and Assessment Services website</u>. The Subcommittee thanks you for adding this statement to your course syllabus.
- **Recommendation:** The Subcommittee noted that students will be receiving feedback via a faculty member and a post-candidacy student, as discussed on page 1. They recommend clarifying in the course syllabus how the post-candidacy student and faculty member will be chosen
- **Recommendation:** The Subcommittee offers the friendly recommendation to update the Student Life Disability Services statement in the course syllabus, as they recently updated it for the 2023-24 academic year. The most up-to-date <u>Student Life Disability Services</u> <u>statement can be found here</u> on the ASC Curriculum and Assessment website.

I will return Microbiology 6030 to the departmental queue via curriculum.osu.edu in order to address the Subcommittee's above feedback.
