Good morning Gina and Jenifer,

On Monday, October 23rd, the Arts and Humanities 1 Subcommittee of the ASC Curriculum Committee reviewed a request to change the number and level of Art 5335 to 3335.

I am pleased to report that the Subcommittee unanimously approved the request with one contingency and one recommendation. As a reminder, the Subcommittee's contingency must be implemented within a revision submitted to curriculum.osu.edu while their recommendation may be implemented when the course is next taught.

- **Contingency:** The Arts and Sciences Curriculum Committee recently updated the list of required syllabus statements for all syllabi within the College to include a statement on religious accommodations. This new, required statement is a result of a directive by the Executive Vice President and Provost and [can be found here on the ASC Curriculum and Assessment Services website](#). The Subcommittee thanks you for adding this statement to your course syllabus.
- **Recommendation:** The reviewing faculty offer the friendly recommendation to update the Student Life – Disability Services statement in the course syllabus, as it was recently updated for the 2023-24 academic year, as well as the Mental Health and Title IX statements. I will return Art 3335 to the departmental queue via curriculum.osu.edu in order to address the Subcommittee's feedback.
