On Monday, September 11th, the Arts and Humanities 1 Subcommittee of the ASC Curriculum Committee reviewed a new course request for Classics 3700.

I am pleased to report that the Subcommittee unanimously approved the request with one contingency and one recommendation:

- **Contingency:** The Subcommittee asks that the GEN Theme "Generic" Goals 1 and 2 and their corresponding ELOs be added to the course syllabus for the GEN Theme Lived Environments. It is a requirement of all General Education courses to have all the GEN Goals and ELOs within the course syllabus. A list of the GEN Goals and ELOs can be found in an easy to copy-and-paste format on the <u>ASC Curriculum and Assessment Services website here</u>.
- **Recommendation:** The Arts and Sciences Curriculum Committee recently updated the list of required syllabus statements for all syllabi within the College to include a statement on religious accommodations. This new, required statement is a result of a directive by the Executive Vice President and Provost and <u>can be found here on the ASC Curriculum and Assessment Services website</u>. The Subcommittee recommends this be added directly to the course syllabus but recognizes that the Marion campus has a helpful link with all required statements.

I will return Classics 3700 to the departmental queue via curriculum.osu.edu in order to address the above feedback.
