On Wednesday, September 20<sup>th</sup>, the Themes 2 Subcommittee of the ASC Curriculum Committee reviewed a new GEN Theme: Sustainability request for History 3706.

I am pleased to report that the Subcommittee approved the proposal with one contingency and three recommendations:

- **Contingency:** The Arts and Sciences Curriculum Committee recently updated the list of required syllabus statements for all syllabi within the College to include a statement on religious accommodations. This new, required statement is a result of a directive by the Executive Vice President and Provost and <u>can be found here on the ASC Curriculum and Assessment Services website</u>. The Subcommittee thanks you for adding this statement to your course syllabus.
- **Recommendation:** The reviewing faculty recommend removing all policies that related to pandemic-era accommodations, as they are no longer relevant.
- **Recommendation:** The reviewing faculty recommend removing reference to the "OSU Standard Scheme" (as found on page 7 of the syllabus) grading scale. Ohio State does not have a standardized grading scale or scheme and instructors are free to utilize a grading scale that best reflects the needs of their individual course.
- **Recommendation:** The reviewing faculty offer the friendly recommendation to update the Student Life Disability Services statement in the course syllabus, as they recently updated it for the 2023-24 academic year. The most up-to-date <a href="Student Life">Student Life</a> Disability Services statement can be found here on the ASC Curriculum and Assessment website.

I will return the proposal to the departmental queue via curriculum.osu.edu in order to address the Subcommittee's feedback.
