Good afternoon,

On Monday, February 19th, the Themes II Subcommittee of the ASC Curriculum Committee reviewed a GEN Theme: Citizenship for a Diverse and Just World proposal for History of Art 4630.

The reviewing faculty voted to not approve the course for the GEN Theme: Citizenship for a Diverse and Just World. Should the department decide they wish to resubmit to the GEN Theme category and make substantial and substantive changes to the course, the Subcommittee has the following feedback:

- The reviewing faculty thank the unit for the revisions provided to the syllabus, but are still unable to see how the course will successfully engage students with the GEN Theme: Citizenship for a Diverse and Just World and allow students to successfully complete GEN Theme: Citizenship ELOs 3.1, 3.2, 4.1, and 4.2. They ask that the course proposer strengthen the connection between the course topics, assignments, and schedule to the GEN Theme: Citizenship for a Diverse and Just World, such as by providing more information on how the artwork studied will relate to citizenship and by including more readings on the topic (however, these are only examples). Particularly, it should be clear and visible to students how they will successfully engage with the Theme and meet the expectations of the Citizenship ELOs.
- The reviewing faculty ask that a cover letter be provided that addresses all changes made as a result of the above feedback.
