## Good evening,

On Thursday, Sept. 21<sup>st</sup>, the Social and Behavioral Sciences Subcommittee of the ASC Curriculum Committee reviewed a course proposal for Economics 1101.

The Subcommittee unanimously approved the request with four contingencies and five recommendations:

- a. **Contingency:** The Subcommittee requests that the department include in the description of the assignments (syllabus pg. 4) information about the format of the exams.
- b. **Contingency:** The Subcommittee requests that the department delete pgs. 19-20 of the syllabus since it seems to include items unintentionally left over from a template. These pages contain language not intended for students ("Optional statements from great syllabi:"; "Encourage your students to let you know if this gets out of proportion on a regular basis. They'll tell you!") and referrals to resources that do not apply to this course (Statistical Consulting for Capstone courses, referral to the John Glenn College librarian, etc.)
- c. **Contingency:** The Subcommittee asks that the department change the transcript abbreviation in curriculum.osu.edu. Transcript abbreviations should be a condensed version of the course title for display on student records, and should give some indication of the course topic to faculty/staff at other institutions, employers, and others who might evaluate a student's transcript.
- d. **Contingency:** The Arts and Sciences Curriculum Committee recently updated the list of required syllabus statements for all syllabi within the college to include a statement on religious accommodations. This new, required statement is a result of a directive by the Executive Vice President and Provost and <u>can be found here on the ASC Curriculum and Assessment Services website</u>. The Subcommittee thanks you for adding this statement to your course syllabus.
- e. Recommendation: The Subcommittee recommends that the department provide more detail on the makeup exam policy (i.e. "...the points from a missed midterm exam grade will be added to your final exam."), since this 1000-level course will inevitably enroll inexperienced undergraduates who may not understand what this means or how such a policy will work in practice.
- f. *Recommendation:* The Subcommittee recommends that the department clarify the nature of project #4 in the description (syllabus pg. 4) and the course schedule (syllabus pg. 7). While it appears that project #4 involves a presentation, it is unclear whether the presentation constitutes the entirety of this project, or there are additional deliverables that are similar to those in projects 1-3.
- g. Recommendation: The Subcommittee suggests that the department provide additional

- information on pg. 4 of the syllabus about how projects will be evaluated.
- h. *Recommendation:* The Subcommittee recommends that the department eliminate the reference to "sections" on pg. 8 of the syllabus, as it appears from the stated course times on pg. 1 of the syllabus that there will not be "sections" or recitations for this course.
- i. *Recommendation:* The Subcommittee recommends that the department note the total number of points at the top of the table on pg. 3 of the syllabus (rather than on pg. 4 under "Descriptions of Major Course Assignments"), as this will make it easier for students to understand the weight of different projects

As a reminder, **contingencies** (in bold above) must be addressed and resubmitted via curriculum.osu.edu before a course can move forward in the approval process. *Recommendations* (in italics above) should be implemented when the course is next taught. I will return Economics 1101 to the department queue via curriculum.osu.edu in order to address the Subcommittee's requests.
