Good afternoon Karl, Kris, and Gabrielle,

On Monday, October 9<sup>th</sup>, the Arts and Humanities 1 Subcommittee of the ASC Curriculum Committee reviewed a new course request for History of Art 4798.03.

I am pleased to report that the Subcommittee unanimously approved the request with three contingencies and one recommendation:

- **Contingency:** The Subcommittee asks that the course instructor provide within the course syllabus a full list of references, readings, and where students can expect to find the required readings.
- **Contingency:** The reviewing faculty ask the course title be the same within curriculum.osu.edu and the course syllabus. Currently, there is a slightly different course title between the two locations.
- **Contingency:** The Arts and Sciences Curriculum Committee recently updated the list of required syllabus statements for all syllabi within the College to include a statement on religious accommodations. This new, required statement is a result of a directive by the Executive Vice President and Provost and [can be found here on the ASC Curriculum and Assessment Services website](#). The Subcommittee thanks you for adding this statement to your course syllabus.
- **Recommendation:** The reviewing faculty offer the friendly recommendation to update the Student Life – Disability Services statement in the course syllabus, as they recently updated it for the 2023-24 academic year, and the Mental Health statement. I will return History of Art 4798.03 to the departmental queue via curriculum.osu.edu in order to address the Subcommittee's feedback.
