The GEN Goals, ELOs, and rationale for the GEN Foundation: Historical and Cultural Studies do not appear on the syllabus that was provided for review. As a reminder, History 3231 is approved for GEN categories Historical and Cultural Studies and Race, Ethnicity and Gender Diversity and GEL categories Diversity - Global Studies and Historical Study. The provided syllabus has only the required elements for GEN Race, Ethnicity and Gender Diversity, GEL Diversity - Global Studies, and GEL Historical Study.

I will return the proposal to the department via curriculum.osu.edu in order to address the remainder of the Subcommittee's contingency.
