The revisions to Slavic/EDUTL 3995 have been received and reviewed. Unfortunately, not all of the Subcommittee's contingencies have been fulfilled at this time. Please see below for additional information:

- The course has not been updated within curriculum.osu.edu for the EDUTL version of the course. Please ensure the course title in curriculum.osu.edu reads as "Transnational Critical Literacy: Media, Race, and Citizenship".
- The religious accommodation statement has not been fully copied and pasted into the course syllabus on page 18. The link which reads as "Policy: Religious Holidays, Holy Dates, and Observations" has not been provided within the syllabus at the end of the statement. While a small part of the entire statement, this link is required by law under the Ohio Revised Code and therefore must be included within the syllabus for approval. You can find this portion of the statement in an easy to copy-and-paste format by visiting the [ASC Curriculum and Assessment Services website](#).

I will return Slavic and EDUTL 3995 to the departmental queues via curriculum.osu.edu in order to address the Subcommittee's remaining contingencies.

Good afternoon,

On Monday, March 4th, the Themes II Subcommittee of the ASC Curriculum Committee reviewed a new Citizenship for a Diverse and Just World and High-Impact Practice: Interdisciplinary and Integrated Collaborative Teaching request for Slavic and EDUTL 3995. Please see below for their feedback.

GEN Theme: Citizenship for a Diverse and Just World

I am pleased to report that the Subcommittee approved the request with four contingencies and three recommendations:

- **Contingency:** The reviewing faculty ask that citizenship be more directly explained within the course syllabus to make it clearer for students how they will be engaging with the topic. Additionally, they ask that the concept of global citizenship be more thoroughly explained in the syllabus, as they were unsure how the course was defining this concept. Do the course proposers, when using global citizenship, mean citizenship on a global stage, or some other definition of global citizenship?
- **Contingency:** The reviewing faculty ask that the Religious Accommodation statement be updated within the course syllabus. On March 1st, 2024, the Arts and Sciences Curriculum Committee updated the required statement to be in compliance with the new statement, which was provided by the Office of Undergraduate Education and vetted by the Office of Legal Affairs. The newly updated statement has been updated on the [syllabus elements page of the ASC Curriculum and Assessment Services website](#).
- **Contingency:** The reviewing faculty ask that the course title be updated in

curriculum.osu.edu, as it was changed within the provided cover letter and the syllabus, but not within the online form.

- **Contingency:** The reviewing faculty ask that a cover letter be provided that addresses all changes made as a result of this feedback.
- **Recommendation:** The reviewing faculty recommend providing questions that showcase to students how they will engage with the concept of citizenship within the course calendar during each course week, as this will help strengthen both the course's connection to the GEN Theme but also highlight to students where they will engage with the Theme.
- **Recommendation:** The reviewing faculty recommend updating the Student Life – Disability Services statement, as it was updated for the 2023-2024 academic year. The most up-to-date statement can be found on the [syllabus elements page of the ASC Curriculum and Assessment Services website](#).
- **Recommendation:** The reviewing faculty offer a friendly recommendation to review the course syllabus for typos and inconsistencies prior to disseminating the document to students. For example, on page 7 of the syllabus, sign-in is misspelled as “sing-in”, and there are several instances where some language references the instructors as “I” (singular) and other times the syllabus language references the instructors as “we” (plural).

High-Impact Practice: Interdisciplinary and Integrated Collaborative Teaching

I am pleased to report that the Subcommittee approved the request.

I will return Slavic & EDUTL 3995 via curriculum.osu.edu in order to address the Subcommittee's feedback.
