Good afternoon,

On Thursday, September 19th, the Themes 2 Subcommittee of the ASC Curriculum Committee and the Theme Advisory Group for Citizenship for a Diverse and Just World reviewed a GEN Theme: CDJW request for Anthropology 5525.

The reviewing faculty declined to vote on the request at this time and ask that the following be addressed in a revision:

- The reviewing faculty note and appreciate the cover letter and rationale provided in the resubmission but ask that the original feedback still be addressed in the syllabus:
 - The reviewing faculty appreciate the course's emphasis on experiential learning but are
 unable to see how the course material will engage students with the concept of
 citizenship. The course is clearly grounding students within community engagement,
 but they are unconvinced, at this time, that the course is engaging students with
 citizenship and meeting the ELOs of the GEN Theme category. They would like to see
 citizenship more clearly woven throughout the course content, materials, and
 structures.
 - The reviewing faculty recommend, as one potential way to further cement the proposal as a course on Citizenship for a Diverse and Just World, having students examine and address the history of community engagement, who has been included and excluded, the history of the IRB process and informed consent, the Belmont Report, and other such relevant topics that can be used to address how the concept of citizenship has been reshaped in this field.
- The reviewing faculty notice that the course description and course content in curriculum.osu.edu do not mention the Theme, which is important not only for future instructors to recognize this as a Themes course, but also for students who will see this course description in the catalog.
- The reviewing faculty recommend that the department use the most recent version of the Student Life Disability Services Statement, which was updated in summer of 2024. The updated statement can be found in an easy to copy/paste format on the Arts and Sciences Curriculum and Assessment Services website. [Syllabus p. 27]
- The Subcommittee recommends that the department use the most recent version of the suggested diversity statement, which can be found in an easy to copy/paste format on the Arts and Sciences Curriculum and Assessment Services website. [Syllabus p. 28]
- The reviewing faculty ask that a cover letter be submitted that addresses all changes made as

a result of their feedback.

I will return Anthropology 5525 to the department queue via curriculum.osu.edu in order to address the above feedback.

• The reviewing faculty ask that a cover letter be submitted that addresses all changes made as a result of their feedback.
