On Tuesday, April 30<sup>th</sup>, the Arts and Humanities 1 Subcommittee of the ASC Curriculum Committee reviewed a new course request for Slavic 5030.

I am pleased to report that the Subcommittee unanimously approved the request with two contingencies and one recommendation:

- **Contingency:** The Subcommittee notes that there appears to be journal assignments required of students (as discussed on page 3 of the syllabus); however, no description of these journal assignments is provided. They ask that a written description of student expectations for these journal assignments be provided within the course syllabus.
- **Contingency:** The Subcommittee asks that a concurrence be sought from the Department of Political Science and the Undergraduate International Studies Program. The Chair of the Department of Political Science is Gregory Caldeira.1 and the Director of the International Studies Program is Marcus Kurtz.61.
- **Recommendation:** The Subcommittee recommends updating the Mental Health statement, as the Suicide Hotline phone number has recently changed. You can find the most up-to-date statement on the [ASC Curriculum and Assessment Services website](#).

I will return the proposal to the departmental queue via curriculum.osu.edu in order to address the Subcommittee's feedback.
