## Hi, Jian,

Thanks for sharing this; I'm always excited to learn more about how departments are integrating career development into their disciplines! In brief, you have concurrence from me, but below I offer just a few comments and suggestions to support this course:

- For the Career Studio, I'd recommend using this site link. Additionally, because of the drop-in nature of the Studio, there is no need for students to officially schedule a visit; they are welcome to drop in at any time. That said, whenever there is a due date, we usually see groups of students coming in around the same time, which can present staffing challenges for us. To remedy that, we keep track of class assignment deadlines and try our best to increase our staffing to accommodate the increased demand; however, that can still present challenges to students who may not always have time to wait. To be most accessible and accommodating to your students, my recommendation is to offer them a choice for their engagement with Career Success:
  - A Career Studio visit OR
  - A one-on-one appointment with a <u>professional Career Coach</u> (they can schedule via <u>Handshake</u>) OR
  - Use the <u>Big Interview platform</u> to upload a resume and job description and it will generate real-time feedback for improvement (the student should be able to produce a report confirming their use of the platform or we can do that on our end if you'd like to confirm they've completed this option)
- To request a workshop from us, please use <u>this link</u> and we can work to get someone assigned to it as soon as possible.
- Finally, this past year we launched our Carmen Instructor Modules, which include a variety of Career Success content that may be useful to you as you finalize the details of this course. I just added you as a student (please tell me if you don't see it in Carmen), so please feel free to peruse and use any content or resources that you'd like.

If there is anything else I or my team can do to support you, please don't hesitate to let me know.
