Good afternoon,

On Friday, January 24th, the Arts and Humanities 1 Subcommittee of the ASC Curriculum Committee reviewed a new course proposal for Music 6850.

The Subcommittee unanimously approved the request with one comment and two recommendations:

- a) **Comment:** The Subcommittee asks that the department rephrase the course's prerequisite in curriculum.osu.edu (under "Prerequisites and Exclusions; prerequisites/corequisites) to "graduate standing in the School of Music and Permission of Instructor", as graduate students do not have majors. [NOTE: This has already been addressed by the School of Music and the ASCCAS Staff].
- b) *Recommendation:* The Subcommittee recommends that the department include in the syllabus a brief explanation of what constitutes a "satisfactory" grade in each of the course's assignments.
- c) Recommendation: The Subcommittee recommends that the department remove or review the links to the GTA Toolkit, Midterm Survey, and other resources from the Drake Institute (syllabus p. 2-3), as many of the links are currently broken.
- As a reminder, *recommendations* (in italics above) should be implemented when the course is next taught. Music 6850 will continue through the approval process to the Graduate School.
