On Friday, February 7th, the Arts and Humanities 2 Subcommittee of the ASC Curriculum Committee reviewed a proposal for Music 7770 to be approved for Distance Learning.

The Subcommittee unanimously approved the request with two recommendations and one comment:

- 1. Comment: The Subcommittee appreciates the clear and well-constructed syllabus that was provided by the School of Music.
- 2. Recommendation: The Subcommittee notes that the in-person syllabus (p. 2-3) contains a more detailed description of the final paper assignment, and they recommend that this language be included in the online syllabus as well.
- 3. *Recommendation:* The Subcommittee recommends that the statement on pg. 14 of the syllabus be titled "Religious Accommodations" rather than "Religious Holidays", per University requirements.

As a reminder, *recommendations* (in italics above) should be implemented when the course is next taught. Music 7770 will continue through the approval process to the Graduate School.
