Good afternoon,

On Friday, Feb. 21st, the Arts and Humanities 2 Subcommittee of the ASC Curriculum Committee reviewed a distance learning proposal for AAAS/History/WGSS 3084.

The Subcommittee unanimously approved the request with two recommendations:

1. *Recommendation:* The Subcommittee suggests that the department outline in the syllabus approximately how long students should expect to spend on the various course assignments/activities each week, so that students may schedule their time accordingly.
2. *Recommendation:* The Subcommittee recommends that the departments use the most recent version of the Diversity Statement (syllabus, pg. 18), which was updated in AU 24 with additional protected categories. AAAS/History/WGSS 3084 will continue through the approval process to OAA.
