On Friday, March 28th, the Arts and Humanities 2 Subcommittee of the ASC Curriculum Committee reviewed a new course proposal for Slavic 3370.

The Subcommittee unanimously approved the request with one comment and two recommendations:

- a) **Comment:** The Subcommittee notes that the course has a number of low-stakes assignments; while they understand the pedagogical reasons behind this, they wonder if there might be a clearer or simpler way to present this to students on p. 9-12 of the syllabus.
- b) **Recommendation:** The Subcommittee recommends providing information in the syllabus (p. 7) about where students can acquire the textbooks and other needed materials, and/or noting that certain materials will be available on Carmen.
- c) **Recommendation:** Due to the recent re-naming of the Office of Institutional Equity, the Subcommittee suggests editing the text and link in the university's Religious Accommodations Statement. A corrected statement (with the new link and new office name) can be found on the [ASCCAS website](#).

As a reminder, *recommendations* (in italics above) should be implemented when the course is next taught. Slavic 3370 will continue through the approval process to the Themes Subcommittee to be reviewed for inclusion in the GEN Theme: Lived Environments category and for the review of the High-Impact Practice.
