Good afternoon,

On Tuesday, April 1<sup>st</sup>, the Arts and Humanities 1 Subcommittee of the ASC Curriculum reviewed a distance learning proposal for 2003 and a new course request for 3088. Please see below for their feedback.

### **History 2003**

I am pleased to report the Subcommittee unanimously approved the proposal with two recommendations:

- **Recommendation:** The Subcommittee recommends that the length of the course exams be provided within the description of the assignment on page 11 of the syllabus.
- **Recommendation:** The Subcommittee recommends updating the Diversity statement as found on page 15 of the syllabus. The most up-to-date syllabus statements may be found on the [ASC Curriculum and Assessment Services website](#).

### **History 3088**

I am pleased to report that the Subcommittee unanimously approved the proposal with two comments:

- The Subcommittee would like to note that they especially appreciated the level of detail in the course calendar, as they believe this will be highly beneficial to students.
- The Subcommittee would like to note that the course title in curriculum.osu.edu (Policing America: Law Enforcement in African American History) differs from that on the syllabus (Policing America: Law Enforcement Traditions, Cultures, and Transformations in African American History). The Subcommittee asks that the Department of History identify the desired title and the staff in the ASC Curriculum and Assessment Services will ensure the proper title is encoded within curriculum.osu.edu prior to the course advancing to the Themes Subcommittee.

Both courses will continue through the approval process (2003 to OAA, 3088 to the Themes Subcommittee).
