Good morning,

On Friday, April 18<sup>th</sup>, the Themes II Subcommittee of the ASC Curriculum Committee reviewed new GEN Theme: Citizenship for a Diverse and Just World requests for History 2642, 3560, & 3025. Please see below for their feedback.

### History 2642

The Subcommittee unanimously approved the request with one contingency:

- **Contingency:** The reviewing faculty were unable to see how ELO 2.2 will be met within the course. They would like to see additional opportunities for students to self-reflect upon their experiences within the Theme woven throughout the course and in the course assignments/assessments.

### History 3560

The Subcommittee unanimously approved the request with two contingencies and one recommendation:

- **Contingency:** The reviewing faculty note that, on page 4 of the syllabus, the explanations on how the course will fulfill ELOs 2.1 and 2.2 has been omitted. They ask that these explanations be added to the course syllabus.
- **Contingency:** The reviewing faculty would like to see further information in the course assignment descriptions (syllabus pages 7-10) that describe, to students, how they will engage in self-reflection to assist in explaining how ELO 2.2 will be met.
- **Recommendation:** The reviewing faculty recommend that the course prerequisites be removed on the course syllabus, page 2, as the prereqs have been removed on the submission form (in curriculum.osu.edu).

### History 3025

The Subcommittee unanimously approved the request with one recommendation:

- **Recommendation:** The reviewing faculty recommend including content within the course on the ripple effects that events within this time period had on Central and South America.

I will return History 2642 and 3560 to the departmental queue via curriculum.osu.edu to address the Subcommittee's feedback while History 3025 will advance through the approval process to OAA.
