Good afternoon,

On Wednesday, May 7<sup>th</sup>, the Natural and Mathematical Sciences Subcommittee of the ASC Curriculum Committee reviewed a new course request for Biology 3730.

I am pleased to report that the Subcommittee unanimously approved the request with three contingencies and one recommendation:

- **Contingency:** The Subcommittee would like to see the communications regarding concurrence from both the Department of Anthropology and EEOB be uploaded into the proposal.
- **Contingency:** The Subcommittee would like to know if this will be an elective option for the Biology major and, if so, the faculty request that CLSE include an updated curriculum map.
- **Contingency:** The Subcommittee noted that Biology 1112 was not listed as a prerequisite option and would like to ask the unit if this was intentional or if it should be added to a list of appropriate prerequisites.
- **Recommendation:** The Subcommittee recommends updating the Religious Accommodations statement (syllabus pages 6-7) and the Diversity Statement (syllabus pages 9-10), as the Office of Institutional Equity has been changed and ODI and the CBSC have been sunset. The updated statements can be found on the [ASC Curriculum and Assessment Services website](#).

I will return Biology 3730 to the center's queue via curriculum.osu.edu in order to address the above contingencies.
